PROCEDURE:

The Buyer, under full authority and responsibility declares that he and his associates have the full capability to purchase the described GOLD product:

1. This transaction will be agreed upon after signing this F.C.O between seller and buyer.
 2. The SELLER shall supply the 850KGS GOLD product from Dr Congo to
 3. The Documentation, logistics and Transportation costs will be handled by SELLER or His representative and BUYER or HIS representative will be participating by monitoring entirely the process from DR Congo whereby the GOLD will be shipped direct to
 4. The SELLER will bring 1 or 2 KG towards the Buyer refinery of choice before the signing of the contract for sole purpose of quality confirmation; the quantity here mentioned will not be subjected to sales.
 5. The shipment and any other related documentation of the 1 or 2 KG will be taken care by the seller; the BUYER will only provide visa and accommodation. After the test and Assay report done in refinery chosen by the BUYER is when the contract will be signed.
 6. The Seller and the buyer representative will go where the consignment is for inspection, the seller will provide all the government royalties from the country of origin, the Buyer will take care of any non-governmental cost: (Smelting, Handling, Security, Assurance and Agent fees).
